General Release and Hold Harmless Agreement:

The undersigned parent/legal guardian desires the above named child to participate in various programs, field trips, events, or activities (hereinafter collectively referred to as an "Activity" or "Activities") operated or sponsored by Christian Formation Ministries, Incorporated and/or My Club (hereinafter referred to as the "Club.") The undersigned parent/legal guardian understands and acknowledges that their child may incur bodily damage or injury while participating in such Activities.

The undersigned parent/legal guardian further understands that the Club will not allow their child to participate in such activities without releasing and holding harmless the Club according to the terms of this General Release and Hold Harmless Agreement.

Further, the undersigned parent/legal guardian requests the Club to allow their child to participate in Club Activities, and in consideration thereof agrees to hereby release and forever discharge the Club, its Officers, Directors, Employees, Agents, and any persons or parties volunteering on behalf of the Club, as well as St. John's Presbyterian Church and/or the owner/operator/agent of the facility/building/property where Club meetings are held and Club activities take place, from all actions, claims, costs, expenses, or damages of any kind growing out of or related to any Activity of the Club (including transportation to and from such Activities) in which their child is involved.

The undersigned parent/legal guardian further acknowledges that this is a full and complete release for all injuries and damages their child may sustain as a result of their child's involvement in Club Activities.
